# 20<sup>th</sup> SESSION OF THE JOINT ACTION FORUM OPENED TODAY AT THE UN CONFERENCE CENTER IN ADDIS ABABA, ETHIOPIA



The twentieth session of the Joint Action Forum (JAF) of the African Programme for Onchocerciasis Control (APOC) opened today 8th December 2014 in the United Nations Conference Centre in Addis Ababa, Ethiopia. This year's session, scheduled to take place from 8th to 12 December is hosted by the Government of The Federal Democratic Republic of Ethiopia.

The JAF is the top governing body of APOC and consists of representatives from participating countries, donors, non-governmental development organizations (NGDOs), the Technical Consultative Committee (TCC), and Merck & Co., Inc. from the private sector. The JAF meets once a year to decide on the overall policy and strategy of the Programme, discuss and approve APOC's plan of action and budget, and review the progress report of APOC.

This year's JAF is unique in that, owing to the new momentum of elimination of NTDs, it is taking place in conjunction with the 8th Global Alliance for Elimination of Lymphatic Filariasis (GAELF) and the first meeting of the stakeholders of the London Declaration, known as the Global Shistosomiasis Alliance.

The main theme of this 20th session is: "Building partnerships to achieve the accelerated elimination of Preventive Chemotherapy NTDs in the African Region." The major issues to be discussed include the progress made by APOC on control towards elimination and the preparation for the new Programme for Elimination of Neglected Diseases in Africa (PENDA).

## **JAF 20 HOST TOWN**

Addis Ababa, the capital city of Ethiopia, is the host town of this twentieth session of the Joint Action Forum (JAF20). Addis Ababa means "New Flower" in Amharic, the official language of the country, a name that was given when the city was



founded by Emperor Menelik II in 1886. His wife, Empress Tayitu Bitul, chose the site for the seat of the throne. The city is populated by people from different regions of the country.

Ethiopia, the second-most populated nation of the African continent, is located in the horn of Africa, and is bordered by Eritrea to the north and northeast, Djibouti and Somalia to the east, Sudan and South Sudan to the west, and Kenya to the south. The nation is a multilingual society with around 80 ethnic groups and almost as many languages, with the widely spoken languages being Amharic, Oromiffa and Tigrigna. Ethiopia has often been called the origin of mankind due to various humanoid fossil discoveries like the Australopithecine Lucy and the Homo sapiens idaltu.

Addis Ababa is the largest city in Ethiopia, with a population close to 3.5 million people. It has the status of both a city and a state. It is where the African Union is based. It also hosts the headquarters of the United Nations Economic Commission for Africa (UNECA) and numerous other continental and international organizations. Addis Ababa is therefore often referred to as "the political capital of Africa" due to its historical, diplomatic and political significance for the continent.

For the visitor that seeks to experience the city, a number of attractions exist like the National Museum where the historical fossils are on display, the mountain-top view of Addis from the top of Entoto Mountain, just 8 kilometers away from the UN compound, and a variety of Ethiopian, other African, European, Mediteranean and Asian cuisine (refer to the back of the newsletter for restaurant suggestions). The city also has several modern malls and traditional souvenir shops for shopping and memorabilia.

#### HIGHLIGHTS OF WHO 2014 REPORT

During the period 2013-2014, steps were taken towards achieving the targets set towards setting up PENDA for the elimination of onchocerciasis and lymphatic filariasis, while supporting Preventive Chemotherapy-Neglected Tropical Diseases (PC-NTDs) from 2016 onwards after the closure of APOC. The Programme governing bodies continued to provide leadership and guidance, and 22 APOC countries received funding in 2013, while 20 were funded for the 1st semester of 2014. In 2014: 124 Community Directed Treatment with Ivermectin (CDTI) projects and six National Onchocerciasis Task Force (NOTF) secretariats benefitted from the Programme's financial support. In the context of scaling up of onchocerciasis and lymphatic filariasis (LF) elimination and support to the control and elimination of other PC-NTDs, 23 NTD national professional officers (NPOs) and technical advisors were recruited to provide technical support to 13 countries. APOC Management paid advocacy visits to some countries and partners in an effort to raise funds for the Trust Fund.

Emphasis was put on the following: disease mapping, CDTI implementation, impact assessment of treatment of onchocerciasis, partnership and collaboration, and capacity building.

Disease mapping results showed that mass distribution of medicines (MDM) for onchocerciasis needs to be launched in all untreated areas of four health districts in Congo and in 11 health zones in DRC. Progress has been made in CDTI implementation. According to the reports of 24 countries 100,693,541 persons were treated for onchocerciasis. Likewise, according to the reports of 17 countries, 113,555,882 were treated for LF. In 2013, for the purpose of assessing elimination of onchocerciasis, a phase 1b epidemiological assessment was conducted in Burundi, Chad and Ethiopia added to previous epidemiological assessments. The results suggested that the foci evaluated may have reached the elimination threshold but this needs confirmation using entomological procedures.

In line with its capacity building activity, a total of 107,275 health workers from 24 countries, all categories combined, were trained at various workshops on CDTI strategy, entomological and epidemiological evaluation, data management, cytotaxonomy and financial management. In these countries, female community drug distributors (CDDs) represent 32.8% of the total number of CDDs involved in MDM campaigns. There is an increase of 2% in female participation compared to 30.8% recorded in 2012. A more detailed report will be presented under agenda item 5 of the meeting.

#### **APOC MISSION AND FONCTIONS**

The African Programme for Onchocerciasis Control (APOC) was set up in 1995 to expand and build on the successes of the Onchocerciasis Control Programme in West Africa (OCP). The overall objective of APOC is to eliminate Onchocerciasis as an important public health disease in all endemic African countries.

APOC is a unique global public-private partnership. Through this partnership with a shared vision, the APOC partnership is working towards a common goal. It is composed of 31 participating African countries and more than 180,000 endemic communities therein; 20 donor countries and organizations; 15 non-governement development organizations (NGDOs); Merck & Co. Inc. and research organizations and institutions.

Member countries are: Angola, Benin, Burkina Faso, Burundi, Cameroon, Central African Republic, Chad, Congo, Côte d'Ivoire, Democratic Republic of Congo, Ethiopia, Equatorial Guinea, Gabon, Ghana, Guinea, Guinea-Bissau, Kenya, Liberia, Malawi, Mali, Mozambique, Niger, Nigeria, Rwanda, Senegal, Sierra Leone, South Sudan, Sudan, Tanzania, Togo and Uganda.

The World Health Organization (WHO) is the executing agency responsible for the running of implementing operations of the programme, while the fiscal agent is World Bank, in charge of fund-raising and management of the APOC Trust Fund.

Since the beginning of the year 2014, the African Programme for Onchocerciasis control (APOC) has been in a process of a two-year transition period before its transformation into a new entity that will support African countries for onchocerciasis and lymphatic filariasis elimination. The new entity that will be launched in 2016 will also contribute to reinforcing the efforts made in the control of other preventive -chemotherapy Neglected Tropical Diseases (PC-NTDs).

#### **CSA 149 MET PRIOR TO JAF 20**



Prior to the opening of the 20th Joint Action and Forum (FAC 20), the Committee of Sponsoring Agencies (CSA) held its 149<sup>th</sup> session in the United Nation Conference Center, in Addis Ababa, Ethiopia from 6 to 7 December 2014.

The following items were discussed: reflections on USAID and DFID statements and the statement of WHO protocol issues and other JAF20 organizational arrangements including JAF scenario, refined budget and scenarios of the strategic plan of action, 2016-2025 of the Programme for Elimination of Neglected Diseases in Africa (PENDA), governance structure of PENDA, reflections of the CSA to JAF20 and the key elements of the presentation on WHO Progress report

The statement of the WHO was delivered to the CSA by Dr Hiro Nakatani, WHO Assistant Director General.

This session as the four previous ones in the context of transition has been expanded to countries, donors and key partners. The main conclusions of this session will be presented during JAF.

The currency in Ethiopia is Ethiopian Birr. The foreign currencies should be exchanged only in authorized banks and hotels. Commercial Bank of Ethiopia has a branch near the conference center (ECA campus). ATMs are available at the UN Conference Center and in most hotels.
